Investigations by this headquarters reveal that a synoptic weather balloon could have been at the location where sightings were reported in the following incidents. In compiling this list consideration was given to the wind direction and speed at the surface and aloft at the scheduled time of balloon release, and the location of the nearest weather station making balloon observations.

1. Project "SIGN" is responsible for the collection, investigation and interpretation of data relative to sighting of unidentified flying objects. Attached Incident Summaries 1 thru 172 from the files of Project "SIGN" are forwarded for study and recommendations as to which of the incidents may be eliminated as balloons released on routine synoptic ascents by the Air Weather Service, the Navy Aerological Service or the United States Weather Bureau. The summaries attached may be retained in your headquarters for working and reference purposes.

2. The Air Weather Service is the only agency of its type that has been asked to assist in the accomplishment of Project "SIGN" except that the United States Weather Bureau has provided information on ball lightning. Research projects in which balloons are used and which are conducted or sponsored by the Army, Navy or United States Air Force are checked by the Intelligence Department of this Command. These checks are usually made direct from the Project "SIGN" Office, MCIAKO-3. These checks are distinct from the check of synoptic balloon flights made by weather service stations of the Air Force, the Navy and the Department of Commerce. (U. S. Weather Bureau) requested of Air Weather Service.

3. It is the opinion of this office that the below listed incidents are those having the greatest possibility of being balloons. This list does not eliminate the possibility that many of the remaining incidents are balloons.

Witness observed a large silver-colored sphere which seemed to arrive from behind his woods and continued to float across his farm. While in flight it seemed to unravel a silver substance which floated earthward. While under observation it disintegrated in mid-air.

NOTE: Witness seemed very conscientious and sincere while relating this incident. Subject arose while witness was talking to a man from this Command (MCIAAP) when an airplane chanced to fly overhead.

Mr. Edward Kadel of MCIAKP advises the following:

Mr. Kadel contacted a man up at Indian Lake, <sup>Ohio</sup> 29 August 1948, who stated that on that date at 5:30 A.M. he observed a large silver colored sphere which seemed to arise from behind his woods and continued to fly across his farm. During flight it seemed to unravel a silver substance which floated earthward. While still viewed by this farmer, the sphere disintegrated in mid-air. This man's name is [REDACTED] of Maplewood, Ohio, [REDACTED] Mr. Kadel further advised that the farmer concerned was a man approximately 50 some odd years of age and appeared to be very conscientious and sincere while relating this incident.

The subject seemed to have arisen while the two men were talking and an airplane happened to fly overhead whereas the farmer then related the foregoing experience. Mr. Kadel could be contacted in the event that any assistance is deemed advisable should a meeting with this farmer be advisable.
