

I would like to inquire about an unusual sighting 15 miles north of Vandalia on October 24 between the hours of approximately 7 and 8 P.M. As you will recall, it was a very rainy, cloudy evening.

My Chemistry went out to see if his aerial was all right as he was having some trouble with the picture on his television. When he looked up, he saw bright flashes, brighter than imaginable, like those that are produced by the helium globes that sit at the end of the runways. These bright flashes appeared about once every second. Even with the use of binoculars, nothing but the bright flashes were visible. He thought that this could be an airplane flying either very low and slow or very high and fast; but he decided against this after considering that there were no red or green taillights visible and that weather conditions weren't favorable for flying. The flashes moved steadily to the south and were not visible after three minutes, even with the use of the binoculars. He then concluded that this was one of your weather balloons, Not being one who believes instantly without proof in UFO's.
