## For \$194, a UFO Package Deal

Anchorage, Alaska (AP) — If you want an inside look at a Japan Air Lines pilot's recent claim that he saw a UFO, the Federal Aviation Administration will send you everything it has about the incident for \$194.30.

The complete package includes tapes of interviews with crew members, spaceship drawings by the JAL pilot and air controllers' statements, even four glossy color photos of regenerated radar data.

The unusual FAA mail-order offer is an effort to cope with enormous public interest in the November sighting, said spokesman Paul Steucke. Since the pilot's claim was publicly disclosed, the FAA's Anchorage office has received information requests from more than 200 members of the news media, as well as 46 requests from individuals.

The agency is also offering 20 individual

items, ranging from a \$50 cassette tape of communications between the controllers and the flight crew to a 30-cent copy of an FAA form summarizing the sighting. Orders of less than \$5 are free. The FAA address in Anchorage is 701 C St., Box 14, Anchorage, Alaska 99513.

JAL Capt. Kenjyu Terauchi reported on Nov. 17 that his Boeing 747 cargo jet was shadowed by two belts of light as it crossed into Alaska on a flight from Iceland. Terauchi also reported seeing a huge spaceship the size of two aircraft carriers. He radioed the sighting to Anchorage FAA flight controllers, who saw what they thought was an object on their radar screens.

Philip J. Klass, an editor with Aviation Week and Space Technology and a longtime investigator of claimed UFO sightings, said the pilot was actually seeing an unusually bright image of the planet Jupiter and possibly Mars.

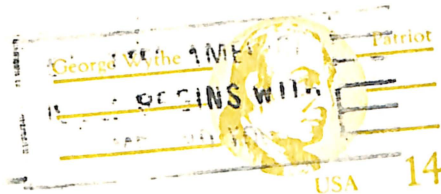
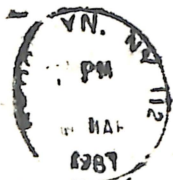

# Scientists Discover How to Read Minds by Decoding Brain Waves

In the most incredible breakthrough in the history of mankind, top American scientists have unlocked the secret of the brain — and are using electronics to read minds!

Employing an amazing technique, University of Missouri researchers have actually been able to monitor brain waves — and decode them into words.

Already, stunned experts are terrified the technique can be turned into a diabolical "tool of terror" — to steal military secrets, read the minds of world leaders,

destroying privacy and ultimately enslave entire populations.

And the CIA is monitoring the stunning development.

"We are aware of the work — and we are following it," CIA spokesman Dale Peterson revealed to The ENQUIRER.

Even Dr. Donald York, a neurophysiologist and co-developer of the technique — admits: "Our findings could be open to abuse in the wrong hands. Secrets of the brain will be secrets no longer!"

In extensive tests, Dr. York and his colleague, speech pathologist Dr. Thomas Jensen, read the thoughts of about 40 subjects.

Their only tool was an electroencephalograph (EEG) machine — a device that picks up brain wave patterns and traces them on paper.

After attaching the EEG's electrodes to a subject's scalp, the scientists asked the person to repeat a specific word. REPEAT

through," declared Dr. Henry Montell, a top physicist at Sandia Laboratories, one of the country's most prestigious research facilities.

But Dr. Montell — who has worked on weapons and computer projects — warned of the technique's dangers.

"Russians could kidnap the secretary of defense, attach him to a brain wave decoding EEG computer — and know all our military secrets, our

weak points and strengths."

He added, "We would have no secrets from the government, the police or the IRS."

Former interrogation expert L.H. Hitchcock — who worked for U.S. Army Intelligence for 30 years — told The ENQUIRER:

"This scares me. Used improperly, or in the wrong

hands, it would be disastrous — a tool of terror."

American military attaches stationed around the world could be kidnapped — and classified information could be stolen by reading their brain waves, he warned.

Dr. Frank Mesch — a nuclear physicist and a chemist who is a top executive with a computer research firm — declared:

"The next step in brain wave decoding is to utilize electromagnetic waves produced by the brain so that it would not be necessary to attach electrodes to the subject's scalp."

The brain waves, travelling like a radio signal, could be tuned in on a receiver operated by a spy — and then fed into a computer that would decode the brain wave patterns into words.

Marcel Vogel, a senior IBM scientist who helped develop advanced memory systems for computers, added: "It's like a James Bond thriller. It is a wonderful breakthrough."

but with potentially disastrous results."

Said Dr. Montell: "With brain wave decoding capabilities plus nuclear energy, a country could rule the world."

But used properly, mind reading could be a great boon to mankind. For example, Dr. York said the technique would allow a stroke victim who lost his powers of speech to communicate.

The patient's brain waves would be fed into a computer, put into words and then transformed into speech played through a loudspeaker. Already Dr. York and Dr. Jensen are programming a computer with a brain wave vocabulary to make this possible.

Dr. George Constant — a psychiatrist and neurologist who is co-director of the dept. of electroencephalography at Citizens Memorial Hospital in Victoria, Tex. — concluded: "It's fascinating... a real breakthrough."

"These patterns were generated when the subject thought the word."

Although the work is still in its early stages, the researchers are already able to identify brain wave patterns for about 27 words and syllables.

"And so far there is no end in sight!" says Dr. Jensen.

"It's an incredible break-

They recorded the brain wave pattern which occurs right before the subject uttered the word. Astonishingly, the researchers found that the word had its own characteristic pattern.

And, incredibly, when the subjects merely thought the word without actually speaking it out loud — the pattern still appeared.

The scientists realized that words, whether just thought of or spoken, had their own unique brain wave patterns.

"We broke the code of the brain!" declared Dr. York.

"We discovered that reading a person's thoughts was a matter of recognizing certain brain wave patterns."

nearly two years ago, was one by President Jimmy Carter, himself interested in the enigma of outer space:

"This is a present from a small distant world. A token of our sounds, our science, our images, our music our thoughts and our feeling. We are attempting to survive our time so that we may live in yours. We hope, someday, having solved the problems we face, to join a community of galactic civilization, and; we send our good will to a vast and awesome universe..."

Carter's interest and concern with outer space and the phenomena it presents stems from the time he was Governor of his home state of Georgia, when he saw a UFO.

His sighting took place in October, 1969. A member of the Lion's Club, Mr. Carter had been waiting with others outside the club's headquarters for their 7:30 meeting to begin.

Describing the UFO, Jimmy Carter added that it appeared "blueish at first—then reddish—but not solid."

At the time, he told the International UFO Bureau in Oklahoma City that the UFO "came close, moved away, came close again, and then moved away. It appeared as bright as the moon."

The UFO was visible for an estimated ten to twelve minutes during which time it changed shape and color. The UFO made no sound and was sharply outlined. The press, in publicizing the incident, said it was "a big, shining light in the shape of a flying saucer hovering overhead."

The incident was mentioned on the Paul Harvey national radio program, and newspapers across the southern portion of the United States headlined it as one of the biggest UFO sightings in history. The object was estimated to be "maybe 300 to 1000 yards away."

Towards the end of 1978, President Carter had asked NASA to take a bigger interest in UFO while they probe the unknown universe. □

On September 5, 1977, when the spacecraft Voyager I was launched, its destination was the far reaches of the galaxy, its mission was to explore three planets. Fifteen days later, Voyager 2 was launched on the same mission—to fly by the galaxies outer planets, encountering Saturn in 1981 and Uranus in 1986.

On March 13, it was announced that the planet Jupiter, the first of the three to be probed, was encountered on schedule.

Discovered were the first active volcanoes (outside the earth's) in the solar system, on Io, one of Jupiter's major moons; its highly sensitive and ultra-sophisticated equipment disclosed that volcanic ash and dust are shooting out of Io's six active volcanoes at speeds more than 1,000 miles per hour.

The knowledge being gleaned by the spacecraft probes as they conduct a scientifically detailed investigation of our neighboring planets, will be of enormous significance.

This thought was prominent in the minds of scientists and world leaders everywhere as news of the probe reached home.

One of the messages placed on board both spacecraft as they left earth veering into the unknown

Stopping Americans' abuse of Valium and other tranquilizers has been the goal of Dr. Sidney Wolfe and his consumer advocate agency for more than a decade.

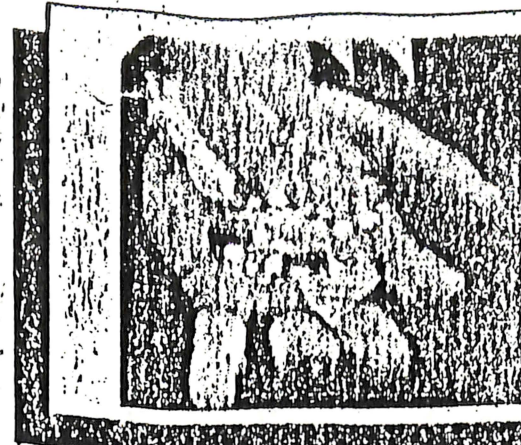
In his new book, "Stopping Valium" (Warner Books, \$5.95), the director of the Public Citizen Health Research Group, along with co-authors Dr. Eve Bargmann and Joan Leylin, attacks drug companies that tout how Valium delivers peace of mind to tense, irritable people.

The nation's 10 million-plus tranquilizer users rarely know the important facts about harmful side effects, Wolfe writes. Valium and similar drugs can cause loss of memory and alertness, impaired driving, confusion, hallucinations, periods of sudden rage, addiction and death.

Through clever advertising, drug companies underplay the side effects of tranquilizers, he says. "Drug companies train doctors, who train people that there are chemical solutions for every ill," Wolfe said in a recent interview in Detroit. "And that's a dangerous philosophy."

INSTEAD, HE said, most benzodiazepines — the basic chemical in Valium and similar drugs — merely mask symptoms caused by stressful situations. "Prescribing Valium or any tranquilizer for a situational problem is like giving a man with a broken leg morphine for his pain and telling him to keep walking," Wolfe writes.

These drugs, designed to calm and relax, should not be used as a substitute for problem-solving or psychotherapy, he says. Instead, he prescribes talking about stress and tension with counselors and friends. "You need a certain amount of stress and anxiety to move the world forward,"

he counsels. "You shouldn't blunt it out."

More than 70 million prescriptions for the tension reliever Valium and its chemical cousins — Librium, Ativan, Centrax, Dalmane, Paxipam, Restoril, Serax, Tranxene and Xanax — were filled in 1980, Wolfe writes.

Of the 10 million Americans who take drugs from the Valium family, 1.5 million may become addicted after prolonged use, facing withdrawal symptoms such as anxiety, convulsions and nausea — symptoms often more serious than those experienced by heroin users. More than 8,000 emergency room visits a year result from tranquilizer addiction, and about 4,500 people each year enter drug treatment centers for care, Wolfe writes.

FOR THOSE hooked on tranquilizers, he suggests a three-step withdrawal plan: a professional evaluation of the

addiction problem; detoxification, or gradual reduction in drug use; and counseling, to cope with stress without drugs. Other sources of help are Veterans Administration medical facilities and branches of the National Institute on Drug Abuse.

He attributes the 45 percent drop in Valium use since 1980 to the nation's focus on communication and to exercise, another method of tension relief.

Wolfe advises tranquilizer users to talk with their doctors about the possibility of addiction, and about why they need the drug. If the doctor tries to say he or she knows best and denies the problem of abuse, then find another physician, he says.

On occasion, Valium and similar tranquilizers are neces-

sary to induce sleep or treat severe epilepsy. In these cases, Wolfe has rules for safer use of tranquilizers, including prescriptions for fewer than 20 pills, no refills, a daily self-evaluation of tension problems and reduced dosages, in consultation with a doctor.

Because tranquilizers dull alertness and can be deadly in combination with other depressants or medication, Wolfe warns against driving, drinking alcohol or using birth control pills while taking Valium or similar drugs. He also says elderly people should not take drugs in the Valium family because the drugs can cause confusion, which is mistakenly branded as senility. Pregnant women should not take the drugs because they can cause birth defects.

And he cautions against taking tranquilizers during times of grief; mental problems could develop, he says. "The grief reaction is delayed and surfaces a year or two later, out of context."

Although "Stopping Valium" offers little that's new, its concise form and clear writing give consumers a comprehensive picture of tranquilizer use and abuse.

Wolfe and Bargmann, a part-time consultant and researcher with the Public Citizen Health Research Group, both specialize in internal medicine. Leylin is the group's lawyer. Wolfe, well known for his fight against drug abuse, also has written "Pills That Don't Work" (Farrar, Straus, Giroux, \$6.95) and "Over the Counter Pills That Don't Work" (available from the research group for \$7; write: Public Citizen Health Research Group, 2000 P. St. NW, Washington, D.C. 20036).

Currently, the research group has pending suits against the federal government and drug companies. In one \$3 million suit, a woman who took prescribed amounts of Valium for 10 years claims Hoffmann-Larocine did not inform her doctor about possible side effects, such as addiction.

ous psychological problems."

Some people who take these drugs actually develop paranoia, an irrational fear of other people, or schizophrenia, a severe mental dis-

order in which a victim loses touch with reality.

Others become extremely passive, almost zombielike, with uncontrollable facial tics and movements of the

body, Dr. Seidenberg explained.

Still others experience radical mood swings, from deep depression to wild euphoria. Often the damage is irreversible, he added.

Schoolchildren are given the drug Ritalin to control problems of hyperactivity, Dr. Seidenberg pointed out, adding:

"This indiscriminate use of these drugs is absolutely unconscionable."

Another psychiatrist, Dr. Peter Breggin, agreed:

"Approximately 10 million Americans are unfortunately receiving these drugs when they shouldn't be.

"Psychiatrists must stop prescribing them. Their use cannot be justified, considering their dangerous side effects, no matter what a person's psychological condition is.

"These drugs are toxic to the brain — they cause a progressive deterioration of the brain."

Dr. D. Frank Benson, a neurologist, agreed: "Most assuredly, major tranquilizers can produce dementia (brain damage) in patient who take them on a long term basis."

Experts interviewed for the article above were Dr. D. Frank Benson, professor of neurology, UCLA; Dr. Robert Seidenberg, clinical professor of psychiatry, State University of New York's Upstate Medical Center, Syracuse, and Dr. Peter Breggin, psychiatrist and author of "Psychiatric Drugs: Hazards to the Brain."

(Washington, D.C.) - A decision is expected soon in the appeal of a Freedom of Information Act lawsuit against the U.S. Central Intelligence Agency for the release of over 200 documents on Unidentified Flying Objects.

The legal effort is being pressed by Ground Saucer Watch, Inc. of Arizona and Citizens Against UFO Secrecy, a Washington-area public interest organization.

The organizations are appealing a Federal District Court decision which allows the agency to keep over 200 pages of UFO documents secret. A hearing in the appeal took place on May 1 in the U.S. Court of Appeals in Washington.

Part of the cost of the litigation was provided by the Fund for UFO Research, Inc., a scientific, nonprofit organization which channels public contributions into UFO research and education projects.

"Organizers of the Fund await the court's decision with extreme interest", says Chairman Bruce Maccabee, a physicist.

## UFO IDENTIFIED FOR A PRICE

*For \$194.30, FAA sends tapes, drawings and color photos*

ANCHORAGE, Alaska (AP) — If you want an inside look at a Japan Air Lines pilot's recent claim that he saw a UFO, the Federal Aviation Administration will send you everything you ever wanted to know about the incident for \$194.30.

The complete package includes tapes of interviews with crew members, spaceship drawings by the JAL pilot and air controller statements, even four glossy color photos of regenerated radar data.

The unusual FAA mail-order offer is an effort to cope with enormous public interest in the November sighting, said spokesman Paul Steucke.

Since the pilot's claim was publicly disclosed, the FAA's Anchorage office has received information requests from more than 200 members of the news media, as well as 46 requests from individuals.

Steucke said the information requests exceed those that fol-

lowed the 1983 downing of a Korean Air Lines jet by the Soviets. "Without a doubt, this thing has had the most inquiries," Steucke said.

For those on tight budgets, the FAA's UFO package can be broken down. The agency is offering 20 individual items, ranging from a \$50 cassette tape of communications between the controllers and the flight crew, to a 30-cent copy of an FAA form summarizing the sighting. Orders of less than \$5 are

free.

"We wanted to be as responsive as we can to the public. We don't want them to spend \$100 for data they don't need," Steucke said.

JAL Capt. Kenjyu Terauchi reported on Nov. 17 that his Boeing 747 cargo jet was tailed by two belts of light as it crossed into Alaska airspace on a flight from Iceland to Anchorage.

In an encounter that lasted

about 50 minutes, Terauchi also reported seeing a third aircraft, a huge spaceship which he said was the size of two aircraft carriers. He radioed the sighting to Anchorage FAA flight controllers.

Philip J. Klass, an editor with Aviation Week and Space Technology and a longtime investigator of claimed UFO sightings, has investi-

gated the incident and concluded that the pilot was actually seeing an unusually bright image of the planet Jupiter and possibly Mars.

Klass said astronomical calculations show that on Nov. 17, Jupiter was extremely bright and was visible precisely where the pilot reported that he saw the UFO.

The FAA is scheduled to release on March 5 the results of its investigation of the sighting.
