21. Manner of disappearance: Turned to talk to friend and then tried to locate objects in the sky again to no avail.
22. Effect on clouds: NONE
23. Additional information concerning object: Saw impression of being linked together but there were no linkage visible.
24. Weather conditions and light at time of sighting: Dark heavy clouds in the South with considerable thunder and lightning. Strong wind blowing. Very light in the North. Clear skies in the north.
25. Name and address of observer: Mrs. [REDACTED], Dallas, Texas
Occupation and hobbies: Housewife, none
- Comments of interrogator relative to intelligence and character of observer (check neighbors, police dept, FBI records, employer, etc.)
Mrs. [REDACTED] gave this agent the impression of being slightly above average intelligence for a housewife. She was very embarrassed by being questioned on this incident but was positive that she had observed the objects. Did observer wear glasses, especially polaroid glasses at time of sighting, or was object viewed through canopy, window, or other transparent material? Glasses were not worn and view was completely unobstructed.

5. What attracted attention to object: Saw fluttering object in sky which flight appeared to be birds.
6. Number of objects and sketch of formation or grouping: Four, in semi-circle, line, one following the other.
7. Apparent size (compare to known object, i.e., sun, moon, thumb or fist at arms length): Approximately size of ordinary dinner plate.
8. Color of object: All objects were completely visible and were a bright silver color.
9. Shape (give graphic description - compare with known object): Appeared to resemble a perfectly flat round disc.

Approximately 45 degrees above horizon.



22. Effect on clouds: None
23. Additional information concerning object: Objects appeared to keep same position in formation and never varied although they cartwheeled independently. Gave general impression of being linked together but any kind of linkage not visible. Black heavy cloud was in the background.
24. Weather conditions and light at time of sighting: Black heavy unbroken clouds in the South but extending from East to West. Western area was dark and it was light in the East.
25. Name and address of observer: Mrs. A [REDACTED]
Occupation and hobbies: Dallas, Texas
Housewife, no hobbies
- Comments of interrogator relative to intelligence and character of observer (check neighbors, police dept, FBI records, employer, etc.)
Mrs. [REDACTED] gave the impression of average intelligence and good character. She was slightly embarrassed by being questioned about the incident due to past publicity given "flying discs". She was positive of seeing some objects. Did observer wear glasses, especially polaroid glasses at time of sighting, or was object viewed through canopy, window, or other transparent material? No glasses were worn and view was unobstructed.
