Dear Mr. Greenwald:

On June 5, 2001, I contacted you by telephone and discussed the fees for search, review, and duplication of documents pertaining to your May 9, 2001, request for UFO sightings in or around Alaska between 1981 and 1988. We have determined that you would be considered a commercial requester and would be charged for all search, review, and duplication of the records. I advised you that approximately 107 pages of documents could be made available to you outside of the FOIA without fees. These documents do not include radar tracking data and simulated radar data for JL1628. It was agreed that you would withdraw your request by either fax (907-271-2800) or E-Mail (jean.Mahoney@faa.gov), and I would forward the 107 pages to you on receipt of your withdrawal.

As of this date, I have not received your withdrawal. If I have not heard from you by July 12, 2001, we will consider your request cancelled. In addition, all documents pertaining to this UFO citing will be destroyed in 30 days from the date of this letter.

This is a Northwest Mountain Region, Air Traffic Organization (ATO), Western Service Area, partial no-records response to your FOIA request of July 28, 2009, made under the provisions of Title 5 United States Code, Section 552. You requested a copy of records regarding “a UFO sighting involving Flight JL 1628 on November 17, 1986” and your previous FOIA request numbered 2001-005317AL. Your request was also assigned to the Alaskan Region for a separate response concerning the previous FOIA request.

A search for records was conducted at the Anchorage Air Route Traffic Control Center, the Anchorage Airport Traffic Control Tower, the Anchorage Terminal Radar Approach Control facility, and the Alaska Flight Services Information Area Group on August 4, 2009. The search revealed no records, documents, or files pertaining to your specific request.

To the extent any records existed, they have been destroyed in accordance with Federal Aviation Administration Order 1350.15C, Records Organization, Transfer and Destruction Standards.

We are enclosing two pages of a document entitled “ASIAS Brief Report.” ASIAS is an acronym for Aviation Safety Information Analysis and Sharing. This document was located in the Western Service Center’s electronic files. This is the only responsive document located.
